The cruising year has started out rainy. Our cruise to the NEW Coles Point Marina, to include the famous Tim's River Shore was washed out for May 21st. Here are a few suggestions of upcoming exciting opportunities.

Coles Point Plantation: A few folks have cruised to this destination, and the live entertainment is nearly every weekend and the new Tim's River Shore has an excellent menu! Slip rental, for Lodge Creek Yacht Club is \$1.50/foot, with a slight charge for electric. Just a few miles up river, and there are floating docks that have been newly installed.

LEGAL NOTICE TO LODGE CREEK YACHT CLUB MEMBERS!

Effective July 1, 2016 all Virginia boaters must have taken a certified safe boating course and have proof of this while boating in Virginia waters, operating any vessel powered by a motor of at least 10 horsepower. This law makes no distinction of age or experience.

Over the past few years, LCYC and Olverson's Marina have sponsored a course for members and the general boating public. While certified classes are taught statewide, once again this season, Lodge Creek Yacht Club and Olverson's Marina will sponsor another class prior to this July 1st deadline.

- ON SATURDAY, JUNE 11, 2016 the 8-hour Boat Virginia class will be held, free of charge, to members and the general public. The class will be held at the clubhouse at Olverson's Marina, and will run from 8am-5pm. Upon completion of the class, all students who meet the requirements of the class will be issued their Boater Certification Card. While there are so many things to learn about safe boating, this course offers basic boater safety knowledge, and meets Virginia requirements. There is no charge for the course, and lunch will be provided by our host, Olverson's Marina.

To register for the class, one simply needs to contact the Marina Office, and request to be added to the roster! That's all there is to it!!

**FROM THE UNITED STATES COAST GUARD
MARINE SAFETY ALERT
DATED MAY 19, 2016
Distressed Distress Signal A potentially dangerous issue.**

The Coast Guard has withdrawn the Certificate of Approval (160.037/23/0) for NAMMO LIAB AB Orange Hand Smoke Distress Signal, and the approval status of this certificate

is now marked as "Former- Do Not Use." This action was taken because the chemical makeup of the signal was changed in October 2013 without Coast Guard approval and the signal that was manufactured is at risk of spontaneous combustion when dropped. These smoke signals may be labeled and marketed as "Polar MK 4" by NAMMO LIAB AB or as "IKAROS" by Hansson Pyrotech. "IKAROS" Hansson Pyrotech is the more current manufacturing name. Datrex Inc., of Kinder, LA, is the only distributor for these products in the United States.

There are approximately 2,790 signals with the potentially defect in the US market. Datrex has removed all of its remaining stock from sale and is working with customers to replace these potentially dangerous signals. Any signal manufactured after October 2013 must be properly disposed of and replaced with a product that satisfies the vessel's carriage requirements.
